Each concessionaire at the Telluride Jazz Celebration agrees to pay \$425 (Four Hundred and Twenty-five Dollars) for their 10' x 10' booth space. In addition, a refundable clean-up deposit of \$100 is required by separate check. The clean-up deposit check will be returned or destroyed upon Park Site Director's approval. A deposit of \$100 (toward the \$425) is required upon application. If accepted it will be cashed at that time. If not accepted, it will be returned. Please include photos of your set up, a description of your wares and pricing. If vending food, you must present proof of approval from the San Miguel County Health department. We cannot consider your application without it. You will be notified of status no later than June 20<sup>th</sup>. If accepted, the entire booth fee and clean-up deposit must be paid in full by June 30, 2010. (Please submit applications no later than June 15, 2010.)

This fee includes two 3-Day Park Passes and 110V power within 100'. Additional 3-Day Park Passes may be purchased for \$90 each or Weekend All Access Pass for \$120 each for your workers. Each concessionaire and any paid or unpaid help must have a pass. Booth space is limited. All booths must be in place no later than 8/6/10 at noon. Concessionaires are responsible for collecting and paying all applicable Town of Telluride fees and taxes during the Jazz Celebration.

Booths must be dismantled and the area cleaned up no later than 12:00 noon, Monday, Aug. 9, 2010, or risk loss of deposit: **this will be strictly enforced**. If possible, dismantle your booth on Sunday evening, Aug. 8th, after the show ends. For any questions, please call Jackie Arguelles at 970.728.7009 or Jackie@telluridejazz.org.
